The Council on the Ageing **Queensland Seniors Month Community Event Grant 2025** are now open, **closing 28 March 2025**.

**Funding of up to \$2,000** is available for events/activities held during Queensland Seniors Month scheduled for <u>October 2025</u>. All projects must align with the Qld Seniors Strategy 2024-29 which includes the following objectives:

- **Connected** to their community through inclusive events that are culturally inclusive, intergenerational, with opportunities to learn through community education, lifelong learning, and digital literacy beyond Seniors Month.
- **Cared for** and supported through the discovery of supports and services and events that encourage older Queenslanders to live active and healthy lives with improved physical and mental wellbeing.
- **Celebrated** in their community and challenging ageism and age bias.

Events <u>must target older people in Queensland</u> and be inclusive of all and accessible to all older people including: Aboriginal and Torres Strait Island peoples, South Sea Islander peoples, People from Culturally and Linguistically Diverse (CALD) backgrounds, People who identify as part of the LGBTI community and People with disability

## Key points:

- Preference will be given to events/activities that:
  - o strongly align with the program objectives see (above);
  - provide a greater reach of attendance;
  - o are open to the general public (not members only);
  - support inclusion and diversity.
- Eligible expenses include: venue hire; catering; guest speakers, entertainment, musicians, artists, workshop facilitators; temporary instructors and tutors engaged specifically for the event; transport to and from the event; marketing and advertising of the event; tools and resources specific to the event or activity, e.g. art or cooking supplies.
- Ineligible expenses include staff wages and organisational running costs; administration fees; any
  activity resulting in a profit; permanent equipment or software, capital works; and/or gifts, raffles or
  door prizes.
- Attachments required: Public Liability Certificate; and budget including quotes where applicable.


