

Transport Operations (Road Use Management) Act 1995

AUTHORISATION

E187683-RSRL

Pursuant to Section 13 of the *Transport Operations (Road Use Management-Vehicle Registration) Regulation 2021*, it is hereby approved **Surf Life Saving Queensland, its regional branches and affiliated branches**, to operate the following unregistered vehicles subject to the below conditions:

Vehicles

- Boat trailer to transport boats and personal watercraft.
- Patrol trailer to store and transport specialised equipment required by Surf Life Saving Queensland.
- Patrol tower trailer a trailer-based patrol tower used for surf life-saving patrols.

Conditions

- This authorisation applies to the types of vehicles listed above with an Aggregate Trailer mass (ATM) not exceeding 4.5 tonnes. The vehicles must only be used for surf life-saving purposes when being towed by standard four-wheel drive vehicle registered to Surf Life Saving Queensland, its regional branches or affiliated branches.
- 2. Adequate public liability on-road insurance cover must be obtained by Surf Life Saving Queensland, its regional branches and affiliated branches and must be current for the duration of this authorization. The public liability insurance policy must include cover for vehicles, personnel and other road users. The public liability insurance policy must expressly cover personal injury to a person caused by or involving an unregistered vehicle that is used on a road pursuant to this authorisation, issued under section 13 of the *Transport Operations (Road Use Management Vehicle Registration) Regulation 2021.*
- 3. The holder of this authorisation agrees to indemnify the State of Queensland against any claim, action or process for damage or injury which may be sustained by reason of the use of vehicle under this authorisation.
- 4. This authorisation does not exempt the driver from the requirements of the *Transport Operations (Road Use Management Driver Licensing) Regulation 2021.*

- 5. This authorisation does not exempt the driver from the requirements of the *Transport Operations (Road Use Management Road Rules) Regulation 2009.*
- The operator/s of the abovementioned vehicles must operate the vehicles in accordance with the conditions for use detailed in the Guideline for the Safe Movements of Non-complying beach trailers used by Surf Life Saving Queensland Form 37 – September 2021.
- 7. A copy of this authorisation is not required to be carried by the driver of a vehicle but must be produced when requested by an Authorised Officer within 48 hours.
- 8. This authorisation is immediately void if any of the above conditions are contravened.
- 9. This authorisation remains valid until 10 November 2027 unless sooner cancelled or revoked by the Chief Executive or their delegate.

Use of the vehicles in accordance with this authorisation will not constitute a contravention of section 10 of the *Transport Operations (Road Use Management- Vehicle Registration)*Regulation 2021.
